Minutes of a meeting of Wembdon Parish Council meeting that was held at St Georges School Wembdon on **11th March 2013** that commenced at 7.30pm when the following business was transacted'

268/12: Confirmation of the minutes of the meeting held at St Georges School on **11th February** the minutes were signed by the Chairman as a true and accurate account of the meeting. In addition the minutes of the **March 6th** extra meeting were approved

Working Groups Reports

Footpaths and Land

269/12: Generally at this time of the year the footpaths are not being used quite as much as they tend to be wet and muddy. However the allotment footpaths are drying out making life a little easier. The issue of the Dog bin addition was raised again and this will be attended to. It was also reported that the hedge in front of the lay-by on Wembdon Hill has now been cleared.

Highways and Speed watch.

Signature of Chairman

270/12: Recent speed checks identified 5 out of 100 cars exceeding the speed limits. The request in the newsletter for additional volunteers for speed watch group has not been very fruitful and no new members recruited recently. Additional warning signs have now been installed. There was some discussion on 20mph in the Inwood area may be something for future discussions and the Parish Council urge all who use this busy area to exercise maximum care at particular times of the day.

Action Points: A Further request for volunteers in stronger language to be included in the next edition of the Parish Paper

Playing Fields

271/12: All very wet at present particularly around the bridge area. Also the end of Wares lane to Great Oaks corner in a poor state. As reported previously there is graffiti on the fencing which Councillor Thake will help with removing. Some concerns also raised about miniature Nitrous oxide gas canisters being left lying around on the playing fields.

Action Points

1. Cllr Thake will assist the Parish Council in removing graffiti

Allotments.

272/12: A number of allotments still vacant but recently some have been taken up including additional ones for existing plot holders. The Parish Council will obtain quotes for additional fencing. Consideration is also to be given to extending the car parking area widening a section of the track and some plots by 2 meters. A formal resolution was made to allow for £250.00 for clearance of plots in a poor state.
