Minutes of a meeting of Wembdon Parish Council meeting that was held at St Georges School Wembdon on **November 11th 2013** that commenced at **7.30pm** when the following business was transacted'

Present: Councillors Cllr M Solomon (Chairman) Cllr A Reed, Cllr T Thake. Cllr T Thayer, and Cllr D Bingham Cllr J Jackson, Cllr N Harrison, Cllr L Burge There were 6 members of the public, and District Councillor I Dyer District Councillor A Bown and County Councillor J Edney.

180/13: To receive apologies for absence: Apologies received from Cllr J Riddle and Cllr J Woods it was resolved to accept these apologies

181/13: To Receive any declarations of interest. There were no declarations at this meeting

182/13: Confirmation of the minutes of the meeting held at St Georges School on **October 14th 2013** these were accepted unanimously as a true reflection of the meeting.

183/13: Observations on the expansion proposal for the village School

Some members of the school community were invited on Friday 8th November to view some outline proposals from the County Council on possible expansion to the numbers and as a result increase the capacity of the school buildings to accommodate the additional children and convert existing temporary facilities to permanent buildings.

Key Observations from the residents of Wembdon

1. Vehicle increase on surrounding roads particularly in Brantwood Road area.
2. The current congestion at certain times of the day is already at

unacceptable levels

3. A Recent observation suggested 100 plus cars at the 3.30 period of the day.
4. Creates a massive inconvenience to local residents in the area
5. Emergency vehicles would not be able to negotiate the area at some times of the day highlighting safety issues
6. Additional strain on the village roads due to EDF plans

Some Suggested mitigation measures

1. Lollicam as used in North Somerset
2. Reduced Speed Limit in the parts of the village affected
3. Installation of a pelican crossing
4. Consideration of a bus scheme (Park and Ride)
5. Parking restrictions on one side of the road during pick up times
6. Improved Cycle Routes
7. Incentives to walk or cycle to school
8. Regular Police / Warden Patrols in the area

Questions that need to be raised with the School

How many of the pupil numbers travel from within the Wembdon Parish ?

It was agreed that County Council would be invited to the January meeting to outline the results of their discussions with the community and any plans that they may have at that stage.

185/13: It was reported that during a recent speed watch exercise that between the hours of 1.30 and 2.30pm there were 54 cars checked with only 2 who were exceeding the limits specified.

187/13: A small working group are investigating the proposals for speed mitigation in and around the village these will include application for 20mph speed limitation and possible purchase of Speed Indicator Devices
