Footpaths and Land

Somerset Flood Victims fund

11/14: A Proposal was put to the meeting for Wembdon Parish Council to make a contribution to the fund that has been set up to support the villages affected by the February flooding in Somerset. After considerable debate and discussion it was resolved to ask the clerk to email details to members and to add the item to the June agenda.

12/14: A national campaign with a 4 point Charter to protect green field development and to ensure Brownfield land resources as a first option on all new building was put before the meeting and will be further discussed at the June meeting.

13/14: Additional cut by our Contractor. It was resolved to approve the additional cutting on the edge of Great Oaks by our contractor Andrew Sutton.

14/14: Persimmon Land acquisition. This has very nearly completed by our solicitors Holley and Steer and a proposal for a 5 year plan suggested and a group will identify the way forward shortly. It is also proposed to get Cannington College involved in this community project. Cllr Thake, Cllr Thayer Cllr Woods , Cllr Bingham and Cllr Riddle will visit the site to identify the proposed way forward

Highways and Speed watch.

15/14: Baseline Data from Andy Coupe

This important data will need to be interpreted by the County but is now available

16/14: Speed Management in the village.

Radar Lux SID : The clerk pointed out that Brent Knoll have capitalised on the County's Change of policy regarding the purchase of these units by individual Councils. BK have purchased a unit and also been able recently to achieve some grant funding. The Parish Council resolved to move this project forward in Wembdon as part of the overall

The initial meeting was intended to identify the problems following on from the recent planning application being agreed to the school expansion. There was recognition by the police that a real problem exists. It also identified that of 345 children 193 arrived by car which is unacceptable. A letter to parents highlighting the problem is a suggested course of action together with re instatement of some yellow lines and replacement of enforcement time boards.

Any proposed travel plan agreed by this group will form part of the wider travel plan needed assist in alleviating some of the considerable concerns highlighted by the Parish

Council.

The Parish Council are very concerned about aspects of the process in consultations prior to the regulation committee's decision to grant the

application. The Clerk advised the Council that having spoken with SALC the process of a judicial review would be prohibitively expensive unless the Parish Council are sure of a successful outcome. At this stage the Parish Council have not taken this matter forward.
