**81/14:** To receive apologies for absence: Apologies received from and Cllr J Woods and apologies were accepted unanimously.

**82/14:** To Receive any declarations of interest. No declarations made at this point in the meeting

**83/14:** Confirmation of the minutes of the meeting held at St Georges School on **July 10<sup>th</sup> 2014** and **with two minor amendments at 66/14 and 67/14** were accepted as a true reflection of the meeting.

**Working Groups Reports**

**Footpaths and Land**

**84/14 :** Concerns arisen over the Church path to NDR ref BW/2 considerable bramble over growth reported particularly amongst the cycling fraternity. This will be looked at further by Chairman/ Cllr Harrison

**85/14:** Cllr A Reed declared a pecuniary interest as the subject matter potentially backs on to one of her properties. Cllr Reed left the meeting at this point

**86/14:** Wares Lane to Greenacre reported problems with breaking up of tarmac ( specifically Vicarage to Wares Lane section) Cllr Thayer to discuss with local property owner.

**87/14:** Cllr Reed returned to the meeting

### Action Point

Cllr Harrison Cllr Solomon to look at the Church path to NDR Path, Cllr Thayer to discuss tarmac Wares Lane with resident,

### Highways and Speed watch.

**88/14:** Concerns raised regarding white posts on the raised section in Church Road. Concerns specifically of a health and safety issue a 3m drop where posts are damaged and this is near play groups and school walking area. The highways will be contacted via Lawrence Hackling by the Clerk to see what action can be taken.

**89/14:** Drains in Church Road near raised pavement are in need of clearance, especially after the recent tar and chippings treatment and highways will be contacted

**90/14:** Continuing concerns about poor parking in Church Road near the exit and entrance to Greenacre the meeting was reminded of the 10m rule and cars should not be parked within 10m of junction. An article will be published in the Parish Paper highlighting the issue to local residents. Richard Newby at Dunball will be contacted further regarding the possibility of warning white lines etc

**91/14:** Transport Forum updates including £50 million budget to be made available for road schemes around the Bridgwater area also the Cannington by pass to start in October of this year. The forum also will allocate provision for cycling schemes and routes in the area. A 20 mph limit during school hours along the Inwood Road to Wembdon Rise is being examined as a part of the Traffic Plan for the School extension. Dates for next meeting 26<sup>th</sup> September 3.45pm

**92/14:** The Clerk informed the meeting that the purchase of speed indicator devices at Brent Knoll had happened but that the protocol for the installation of them was under review and that they are not able to be

activated yet, this should be a consideration for Wembdon prior to any purchase considerations.

**93/14:** More formal speed watch signage proposed and showed to the meeting and it was resolved to give the go ahead.

### **Matters of Consideration**

#### **102 /14: Wembdon Village Hall Trust updates**

Funding now in place and contractor Woodlands appointed to undertake the project. Main access for the development will be via the NDR once the new bridge has been constructed. The Village Hall construction is scheduled to be completed in 52 weeks and the Village Green and associated pitches should be available for light use from Spring 2016.

Bridgwater College, Land Based Studies Group based at Cannington Campus will be invited to assist in the design and implementation of a Community Parkland area to be constructed in the newly acquired Persimmon Land. It was agreed that the Chairman would organise a general clearance of the bramble and fencing this area for security purposes as soon as possible.

#### **103/14: CIM Funding**

Access to funds for community groups and projects can be applied for through a robust scheme that will need to demonstrate strong community benefits through a procedure available on the West Somerset Council Website. The Council will be supportive of any community groups wishing to access these funds but to be successful, the community groups will need to take the lead.
