#### **NEWS IN BRIEF**

- Wembdon was honoured with a visit from the Lord Lieutenant of Somerset, when she came to officially open the new fully accessible roundabout and trampoline in the playing field.
- Your Parish Council were re-elected on 2<sup>nd</sup> May. Details of all of your Councillors and the Parish Clerk are noted later in this Parish Paper
- The wall adjacent to the allotments track collapsed during a violent storm a few months ago. The damaged section has now been demolished and a contract issued for the reconstruction work.
- Our Neighbourhood Plan, prepared over the past 18 months by the Parish Council and a team of local volunteers has now been finally approved for a public vote by all residents of Wembdon Parish on 4<sup>th</sup> July. Voting will take place in The Parish Centre as usual and we hope you do come out and vote. The key policies and aspects of the plan are detailed later in the paper.
- The Give a Day team is inviting residents to join them and establish a litter pick team
- The Trustees have completely revamped the front of Wembdon Village Hall with new tarmac surfacing for the car park, planting of specimen cherry blossom trees as well as Portuguese laurel bushes and has now wooden fenced the whole area.
- Wembdon held its first beer and cider festival at the Village Hall, which was a resounding success. Sound levels were maintained to within agreed limits and very many positive comments have been made by our whole community.
- Your Parish Council continues to lobby the County Council for improvements to the zebra crossing on Wembdon Rise and for the introduction of additional speed management measures to further reduce the small number of drivers racing through our village.
- Sedgemoor District Council's Local Plan for 2011 2032 was formally adopted in February. Developers have submitted planning applications for the West Bridgwater sites on both sides of the A39, and your Parish Council have strongly objected to aspects of both proposals.

## Opening of the Access for All facilities at The Green Wembdon

On 17th May the Lord Lieutenant Mrs Annie Maw cut the ribbon on our new playground equipment. The totally inclusive roundabout and trampoline were provided by G L Jones and funding was given by the National Lottery Community Fund.

The Access for All Wembdon project also includes;

- The recently completed Changing Places toilet, again thanks to the National Lottery.
- The footpaths connecting the village hall to the play area, as well as other parts of the village
- Solar powered lighting to the footpaths and surroundings
- Newly surfaced car park and trees/shrubs
- Security CCTV

Louise Jackson with her sons Finley and Jett demonstrated the play equipment, and Finley and Jett presented a bouquet of flowers to Mrs Maws.

  - SDC have determined that Cokerhurst Farm will be developed.

- Vote NO to reject the Plan, if you don't think Wembdon's local policies are needed
  - All new planning applications would then be judged only against the policies in SDC's Local Plan

### Wembdon's Neighbourhood Plan Policies

#### **Policy WB1: Design**

New developments will need to demonstrate how any new proposed building(s) will contribute positively to the character of the existing built form and the atmosphere of the village, through use of the following where applicable:

- 1. Ensure a mixed palette of locally distinctive external materials including where appropriate the use of locally sourced red sandstone (or suitable equivalent) within key views and frontages;
- 2. Encourage soft, green landscaping in preference to concrete and tarmac where practicable;
- 3. Appropriate densities to reflect the surrounding built form, setting and context;
- 4. New and additional tree planting of appropriate species to reflect the existing street scene within the village; and
- 5. Avoid the loss of sandstone boundary walls or, where this cannot be achieved, include proposals for re-use of the material on site.

#### **Policy WB2: Locally Important Viewpoints**

New development proposals should seek to protect and, where appropriate, enhance the objectives (contained within Appendix E) of the following Locally Important Viewpoints (as defined in Appendix F):

- 1. Views looking north from Wembdon Hill towards Perry Green and Chilton Trinity
- 2. West Wembdon Views to the west of Wembdon Village looking west towards the Quantock Hills and south towards the A39 Quantock Road including the A39 corridor
- 3. Wembdon Village Hall and Church Road across the Green

### Policy WB3: Sustainable Transport and Parking Provision in New Developments

Major new development will be expected to incorporate new walking and cycling links, or improvements to existing, in relation to connections between one or more of the following locations within the development itself and/or by means of planning obligation where the statutory tests for such obligations are met:

- 1. The residential allocation at Cokerhurst Farm, Wembdon Village and Wembdon Village Hall
- 2. Wembdon Village and local education and employment facilities
- 3. The A39 Cannington cycleway and Wembdon Village

Major new development will need to be supported by an appropriate Transport Statement or Assessment which identifies potential adverse impacts on traffic speeds and volumes along Wembdon Hill and Wembdon Rise as a result of the proposals. Where there is a potential for adverse impacts, appropriate and proportionate mitigation measures will need to be delivered through the new development and priority would be given to the above identified routes.

Development proposals which include measures to reduce the speed and volume of traffic within the Neighbourhood Plan Area will be supported.

Other than on land shown on the adopted proposals map as allocated for residential development in accordance with Sedgemoor Local Plan Policy B2, development proposals shall provide for the following car parking provision per dwelling unless site-specific viability evidence demonstrates that this cannot be achieved or that there would be a demonstrated adverse effect on design and/or residential amenity:

#### **Policy WB4: Community Facilities**

Proposals to enhance, improve and extend community facilities will be supported where theycomplement existing facilities, and in particular at the following Important Community Facilities as identified on Plan 1 and the accompanying inset plans contained in Appendix A.

- 1. St George's Church Ground and Parking Area
  - rea 4. The Cottage Inn

7. Greenway Garage

2. The Parish Centre

- 5. Wembdon Village Hall and Village Green
- 3. St George's C of E Prinmary School
- 6. Village Shop and Post Office

#### **Plan 1: Important Community Facilities**

Development proposals resulting in the loss of, or which compromise the viability of, facilities identified on Plan 1 will not be permitted unless it can be demonstrated that the land and/or facility is no longer required for its sports, leisure or recreational use and that the proposed development provides recreational or community benefit equal to the long-term value of the sports, leisure or recreational facility that would be lost.

#### Policy WB5: Delivery of new retail and community facilities

The following additional retail and community uses will be permitted where they will contribute positively to existing facilities:-


- 1. Restaurant/café
- 2. Convenience store
- 3. Pharmacy
- 4. Doctor's surgery
- 5. Children's play area

Regard should be had to the objectives of the Community Strategy once it is adopted.

Where there is potential to undermine the viability of an existing community facility, to which Policy WB4 applies, planning permission will be refused unless it is demonstrated that the benefit of the proposed retail or community facility would outweigh the loss of, or risk to the viability of, an existing facility.

#### **Policy WB6: Local Green Spaces**

The following areas are to be designated as Local Green Space and are identified on Plan 2 and the accompanying inset plans contained within Appendix C:



Plan 2: Local Green Spaces

#### **Policy WB7: Rural Diversification**

New small-scale development to provide ancillary uses, including but not limited to the following buildings that are required to support the diversification of existing rural businesses, will be approved:

- 1. Café or restaurant
- 2. Farm shop
- 3. Business start-up units
- 4. Leisure
- 5. Holiday accommodation

Wembdon Parish Council, in conjunction with a steering group made up of Wembdon residents and Parish Councillors, has developed this Neighbourhood Development Plan (the NDP).

The NDP is our shared vision of the future. It is a structured framework which the Parish Council can use to preserve and improve the Parish as a place in which to live and work over the coming years.

It adds detail to Sedgemoor District Council planning policy and, following a successful referendum, will be used alongside the Sedgemoor Local Plan to help determine planning applications in the Parish.

The NDP aims to preserve and enhance the character of Wembdon, including the landscape, trees and green spaces. It addresses residents' concerns about traffic speed, volume and parking. If there is new development in the village, we want it to be designed to look and feel like Wembdon, with appropriate density of housing, good green spaces and adequate car parking. We also want it to contain enough affordable housing for Wembdon people who need it.

Once adopted the NDP will also enable the Parish Council to claim a larger percentage of any Community Infrastructure Levy money available to Sedgemoor District Council, which it can then use on projects to benefit the community.

We are very grateful to all of the residents who have taken time and trouble to tell us how they want our Parish to be in the future. The Parish Council will seek to deliver this shared vision to the best of its abilities and to make Wembdon a thriving, sustainable, friendly and safe place for us to live in.

#### THE ALLOTMENTS TRACK WALL

Following a night of severe storms, a section of the red Wembdon sandstone wall adjacent to the allotments track started to collapse. Perhaps fortunately the fall was in the direction of the track, rather than over the high quarry cliff face but action needed to be taken immediately. The area was made safe that same morning and following a site inspection, a detailed structural report was prepared by a Consulting Engineer. This identified the extent of the immediate damage and established a protocol for long term repairs. The immediate area of concern was a length of wall of about 11 metres and this has now been fully dismantled, and a local building company has been instructed to complete the reinstatement work





The Council decided that as there was the possibility of providing some excellent views to the South of the track and over to the Quantock Hills, it was preferable to replace the wall to a height of about 2/3 of the current level with the recovered red sandstone and then add a section of railings to bring this to the current height to provide adequate safety.

Once this work has been completed, the Council proposes to clear the long established and overgrown ivy to enable a detailed inspection of the rest of the wall to be completed. We can then carry out repairs as necessary to the remainder of the wall in a planned manner to minimise any impact that this would have on the Parish precept.





#### GIVE AN HOUR - or perhaps a MORNING

Our regular team of volunteers have been busy working with the Village Hall Trust and Wembdon Cricket Club in providing our Village Hall with a car park and entrance that we can all be proud of. Constructing wooden fences to protect the tarmac edges and gates to the overflow car park in preparation for the tarmac surface to be installed.





The team planted specimen flowering cherry in the main beds and over 100 Portuguese laurel formed the hedge plants around the borders.

#### REPORT FROM THE SPEEDWATCH TEAM

Latest evidence from the Speed Indicator Device: Wembdon Hill – towards Cannington the average speed recorded over 3 weeks was 23.4 mph in the 30-mph zone BUT we recorded a vehicle travelling at 65 MPH on April 15th at 07:00 and many others in excess of 55 mph!

The Speedwatch team have been active on Wembdon Hill recently and recorded those drivers in excess of 36 mph – their details are passed to the police, along with notes if they have no tax, insurance or MOT.



The team is often approached by residents asking if we can operate in other areas of the village. We have <u>four</u> risk-assessed sites (by the police) and we can only work from there. Whilst we are happy to discuss what we are doing, it is quite distracting if people stop and chat as we must be constantly alert to record vehicle registration numbers, make, model, speed & direction of travel etc. We are, however, very grateful to those of you who have kindly brought us cups of tea, thanked us for our work and given us a "thumbs-up" as you drove past!

I'm sure many of you are as frustrated as we are at the speed of traffic that dashes through the village. The Parish Council continues to work tirelessly with District and County Councillors to find a solution to this problem.

### WEMBDON NEIGHBOURHOOD PLAN -A PERSONAL VIEW

In autumn 2017 I was invited to join the Wembdon Neighbourhood Plan Steering Group. It seemed like a good idea. Neighbourhood Plans allow communities to set planning policies to control the future development and growth of the neighbourhood - and in Wembdon there was a particular need for a Plan.



After many years of resolute opposition from the Parish Council and Wembdon residents (including me) because of the effects on traffic and the character of the village, it had become apparent that we had lost the battle and development at Cokerhurst Farm was inevitable. Many of us still think the decision was wrong – but if we couldn't stop it we could, by having a Neighbourhood Plan, control

some aspects of the development and make it look and feel like Wembdon.

When I joined the project my hopes were quite simple – to preserve the character and village status of Wembdon, to prevent any further housing development and to preserve all of our green spaces and important village assets.

We soon found out that there are lots of restrictions on what can legally be included. For example our Plan could not contain anything



which conflicts with Sedgemoor Local Plan (such as the Cokerhurst development) and there are limits on how much green space can be designated. Nor were we allowed to include any measures to deal with traffic speed.

We needed to make sure the Plan reflected the views of Wembdon residents so we held 13 meetings, did postal surveys and asked for comments via email and Facebook. The overwhelming majority wanted to keep Wembdon as it is and the biggest concern was



about traffic speed, congestion and parking. We also consulted 244 other parties who might have an interest in Wembdon. Some of them had different ideas to those of Wembdon residents but we were obliged to take all responses into account.

We wrote the Plan – and then re-wrote it twice to take into account the views



expressed in our consultations. When we submitted the final version to the District Council I felt that, despite the restrictions imposed by the regulations, we had a really good Plan which reflected what the people of Wembdon want.

The next step was to send the plan to an independent examiner. I was disappointed when the examiner's report said that we should change

two of our Neighbourhood Plan policies. He said the policy to give priority for

Wembdon people when affordable housing is allocated must be removed from the Plan and the policy to set a minimum number of parking spaces in any new development could apply to the rest of the parish but not to Cokerhurst Farm. The steering group thinks the examiner's interpretation is wrong but if we went against his recommendations we would be open to a legal challenge – so we had to find a different way.





The story does have a happy ending. Because the Cokerhurst developers knew the Plan was coming it has had an influence on their intentions. As a result, their planning application has included the higher parking allocation which we wanted and they have agreed to include local priority for affordable

housing in their legal agreement with Sedgemoor District Council. So we have got what Wembdon wanted.

These measures, together with our policies which will protect local viewpoints and green spaces and also our village hall, parish centre, church, school, pub and shop make me feel that it was a year well spent.

#### Hinkley Connection Project – surveys in your area

National Grid will be upgrading the existing pylons between Hinkley and Bridgwater.

The work for this is scheduled to start in mid-2022. In preparation and to help us plan the work, we will need carry out a number of surveys.

In your area we are undertaking ecological surveys to look for protected mammals, great crested newts and dormouse. We're doing walkover surveys and water sampling at various pond locations, starting on 3 June 2019 for two weeks.

We will then monitor dormouse activities from June 2019 to December 2019

Any required access to any privately-owned land has been agreed with relevant landowners.

We want to keep you up to date with what we're doing, and we will be back in touch with further information before starting work on the pylons.
